# ON-LINE SHORT PAPER SUBMISSION

The Scientific committee of 7<sup>th</sup> Congress of Pharmacy in North Macedonia with international participation decided that submitted scientific works should be in form of short communications (papers) as they will be published in a special issue of *Macedonian Pharmaceutical Bulletin*, vol. 66 (Suppl 1), 2020. Short papers will be labelled with a Digital Object Identification Number (DOI).

All submitted short papers will undergo a peer-review by the members of the International Scientific Board and will be published upon their acceptance.

- Deadline for short paper submission and registration: March 15<sup>th</sup>, 2020.
- Acceptance of the short paper: April 1st, 2020.
- Accepted short papers will be presented from May 14-16, 2020, either orally or in poster form.
- Short paper submission is not dependent upon payment of registration fee.
- Publication is dependent upon payment of registration fee. Your paper won't be published if you don't pay the
  registration fee until March 15<sup>th</sup>, 2020.



# AWARDS/POSSIBILITIES

#### **Student Session**

Students of five-years integrated studies of Pharmacy are invited to present results of their graduate thesis or any research activity they participated in during their studies, as an oral or a poster presentation. The student session will be held on May 14<sup>th</sup>, 2020. The presentations will be evaluated by an international expert jury, with the best oral and poster presentations being awarded. During the short paper submission process students should select the option *Student session*.

## **Young Scientist Grant**

Young researchers under the age of 35 are eligible to apply for the **Young Scientist Grant**. Please select the appropriate box during registration. The granted young scientists will be released from registration fee. Young Scientist Awardees will be requested to prepare an oral presentation in the appropriate session and will be invited to extend the short papers for publication in regular issue of **Macedonian Pharmaceutical Bulletin**, indexed by DOAJ and EBSCO.

#### **E-Posters**

Those who are not attending the event physically but willing to publish their research work in the Congress proceedings can register under this category. E-Posters will be on display throughout the Congress poster sessions on multi-media screens situated in the poster area.
